The CARES act was enacted on March 13, 2020. The emergency student funding is available to students that were enrolled and attending classes and maintained Satisfactory Academic Progress. All students that have either completed or continue their enrollment are eligible for funding. Students on an approved Leave of Absence are also allowed to participate. Pineville Beauty School disbursed funds evenly across the student body to those eligible students after receipt on May 27, 2020. The remaining funds will be distributed to current and future students. These funds are to be used for expenses incurred because of campus disruption due to COVID-19.

The emergency student funding provided to each eligible student is for expenses related to the disruption of campus operations due to the corona virus, such as food, housing, course materials, technology, health care, and child care expenses.
