

# STUDENT-RIGHT-TO-KNOW: COMPLETION, GRADUATION, AND TRANSFER-OUT-RATES FOR FIRST- TIME, FULL-TIME GRADUATES AND PLACEMENT METHODOLOGY AND INFORMATION

The U.S. Department of Education requires institutions to inform prospective and enrolled students of completion/graduation rates, desegregated completion/graduation rates, and retention rates for certificate or degree-seeking, first-time, full-time, undergraduate students. The U.S. Department of Education also requires institutions to inform prospective and enrolled students of its placement information. The following information are the completion/graduation rates of certificate or degree-seeking, first-time, full-time, undergraduate students:

### OVERALL GRADUATION RATE AND TRANSFER-OUT RATE

The overall graduation rate is also known as the "Student Right to Know" or IPEDS graduation rate. It tracks the progress of students who began their studies as **full-time, first-time degree- or certificate-seeking students** to see if they complete a degree or other award such as a certificate within 150% of "normal time" for completing the program in which they are enrolled.

Some institutions also report a transfer-out rate, which is the percentage of the full-time, first-time students who transferred to another institution without completing at the current institution.

Note that not all students at the institution are tracked for these rates. Students who have already attended another postsecondary institution, or who began their studies on a part-time basis, are not tracked for this rate.


Percentage of Full-time, First-Time Students Who Graduated or Transferred Out Within 150% of "Normal Time" to Completion for Their Program

### **GRADUATION RATES BY TIME TO COMPLETION**

Graduation rates can be measured over different lengths of time. "Normal time" is the typical amount of time it takes full-time students to complete their program. For example, the "normal" amount of time for many associate's degree programs is 2 years. Not all students complete within the normal time, so graduation rates are measured by other lengths of time as well, including "150% of normal time" (e.g., 3 years for a 2-year program) and "200% of normal time," or twice as long as the normal time (e.g., 4 years for a 2-year program).





The following are desegrated rates of completion/graduation rates of certificate or degree seeking, first time, full time, undergraduate students desegrated by:



## PLACEMENT METHODOLOGY AND INFORMATION

The Pineville Beauty School is required by the U.S. Department of Education (ED) to make available information regarding the placement of and types of employment of the graduates of the school's certificate programs to prospective students.

## Job Placement Methodology:

## Graduates:

Graduate rates are calculated by subtracting the number of students who received a certificate from successfully completing a program at the Pineville Beauty School (Graduates) from the number of students who were scheduled to graduate in a program at the Pineville Beauty School (Scheduled Graduates) during the reporting period.

Scheduled Graduates – Graduates = Graduate Rate

## Graduates Who Are Available For Employment:

Graduates who are available for employment are calculated by subtracting the number of students who received a certificate from successfully completing a program at the Pineville Beauty School (Graduates) from the number of students who were scheduled to graduate in a program at the Pineville Beauty School (Scheduled Graduates) during the reporting period.

Scheduled Graduates – Graduates = Graduates Who Are Available For Employment

## **Graduates Employed Within Their Field:**

Graduates employed within their field are calculated by taking the number of students who graduated and successfully obtained a certificate from successfully completing a program at the Pineville Beauty School and who were employed in a field for which training prepared them within 180 days of obtaining their certificate (Graduates Employed Within Their Field) from the number of students who received a certificate from successfully completing a program at the Pineville Beauty School (Graduates) during the reporting period.

### Job Placement Calculation:

In order to calculate the job placement rate, you must take the number of Graduates Employed Within Their Field

from Graduates Who Were Available For Employment.

Graduate Who Were Available For Employment / Graduates Employed Within Their Field = Job Placement Rate.

Placement information is obtained by conducting employer surveys, verification logs, and through social media

platforms. Employment for students who have graduated from the Cosmetology course/program have found

employment in salons.

The following is the placement rate for students who graduated in 2020 and found employment in their field:

Placement Rate: 82%
